## PARKING LOT SNOW REMOVAL RULES

After a snowstorm, parking lots are often left with significant snow buildup between and around parked vehicles. In our ongoing effort to provide residents with safe, high-quality service, the Worcester Housing Authority (WHA) has implemented a **Special Snow Removal Program** for designated parking lots.

### PROGRAM PURPOSE

The intent of this program is to **fully clear snow from parking lots after a snowstorm** by requiring residents to temporarily remove their vehicles. This allows for safer conditions and maximizes available parking spaces that are otherwise lost due to snow accumulation.

Please note: **This Special Snow Removal Program is in addition to WHA's regular snow removal operations that occur during active snowstorms.** Parking lots may also be **treated for ice when weather conditions require**, even if snowfall amounts do not meet the threshold for full snow removal.

### RULES

- If snowfall **has stopped by 8:00 a.m.**, the Snow Removal Program schedule will be in effect **that same day**.
- If snowfall **continues after 8:00 a.m.**, the Snow Removal Program schedule will begin **the following day**.
- If snowfall occurs during a **weekend**, the Snow Removal Program schedule will begin on **Monday**.
- **All vehicles must be removed by the posted Snow Removal Time** on the scheduled day following a snowstorm.
- Parking lots may be **plowed, sanded, or treated for icy conditions** when weather conditions warrant, regardless of snowfall amounts.
- Vehicles may return to their respective parking lots **up to two (2) hours after the Snow Removal Time**, depending on the amount of snow to be removed and resident cooperation.

- Vehicles **not removed by the designated Snow Removal Time will be towed at the vehicle owner's expense.**
- The **resident is responsible** for removing their vehicle; WHA is not responsible for vehicle relocation.
- Residents who will be away must **make prior arrangements** to have their vehicle removed in the event of snow.
- There must be a minimum of **two (2) inches of plowable snow** on the ground for the full Snow Removal Program to go into effect.
- This Snow Removal Program **applies only to parking lots.**

*(Timeframes are approximate and may vary based on snowfall amounts and resident cooperation. Residents are encouraged to move their vehicles at least **30 minutes prior** to the scheduled time to ensure operations run smoothly.)*
